MESSAGE FROM THE EXECUTIVE DIRECTOR

Cascade Connections will never forget the year 2020 – it kept us on our toes from start to finish! How bittersweet it is to recall the abundant hope and anticipation with which we began a year that quickly became one of the most challenging eras in our organization's history.

When the pandemic first broke out in Washington and became a staple of household conversation across the country, many of us did not anticipate the extent to which COVID-19 would change our daily lives. As we moved into March, however, the economy slowed down significantly, and COVID-19 restrictions forced some small businesses to close. As a local non-profit agency, we looked for ways to cut costs due to the economic recession.

The pandemic's negative impacts drastically changed our normal business routines. We locked down our residential sites and put together safety protocols in order to protect our clients. Many were unable to go out into the community or visit their families. The governor's stay-at-home order forced us to pause many of our important vocational services for quite some time.

However, as often happens, adversity proved a blessing as well as a curse. One blessing in disguise was that we discovered ways for people to work and meet from home. The shut-down also gave us more time to develop our online training programs – something we had not had sufficient time to do during normal operations. We took this opportunity to carefully evaluate and establish a new program structure, making us better able to train those who wish to serve individuals with developmental disabilities.

Despite the unexpected blessings, the inevitability of change remained very difficult at times. Throughout this past year, we said goodbye to some of long-time clientele and staff members. These changes were very hard for us, but the losses did help us appreciate the good moments we had together. We remain faithful that life's ups and downs may challenge us along the way, but that better times always await us.

We are so thankful for the many community and business partners who have helped make our mission possible. You have supported us through many storms over the years, including this one. Your support matters to those we serve, our staff, and society as a whole. We are immensely grateful for your ongoing commitment to our mission of empowering individuals with disabilities to enhance their quality of life.







VOCATIONAL REHABILITATION SERVICES

Individuals are referred by the Division of Vocational Rehabilitation (DVR) and contract for short term services, including:

- Independent Living Skills
- Community based assessments
- Job placement
- Retention services

The DVR is a state-wide resource assisting people with disabilities to prepare for, secure, maintain, advance in, or regain employment. DVR partners with Cascade Connections and businesses to develop employment opportunities for customers.



LONG-TERM VOCATIONAL SERVICES

Individuals with developmental disabilities receive services including:

• Discovery – Informational interviews, job shadows, community based assessment

- Job Development
- Retention Services

Foundational Community Supports (FCS): A program offering benefits for supportive housing and supported employment for Medicaideligible beneficiaries with

complex needs. Community Inclusion Services: Available to individuals who are of retirement age (62 years or older), or over 21 years of age and have tried employment services for nine months or more.




