Without a wheelchair van, many times people are just left at home, or they must leave their motorized chair behind. This limits a person's freedom to be able to move about the community without having someone pushing them.

Mark is a member of the Cascade Connections Board of Directors. Mark is an active community member and wanted more access to that community for himself and others who use motorized wheelchairs. Mark challenged the Board of Directors to set a goal to raise the funds to purchase a new wheelchair van in 2017. Cascade Connections took on this goal and began to share the need with others.

Cascade Connections' mission is to empower individuals with disabilities to enhance their quality of life. They accomplish this mission by supporting people to both live and work in Whatcom County. If you can't get out your community, how can you become a part of it? The freedom to move freely within our community allows people to have power and choice over their lives and to choose who to build relationships with and how to spend their time. Mark knew that Cascade Connections buying a new wheelchair van would not only

create greater opportunities for himself, but it would also create those same opportunities for many others as well.

Mark created a campaign with the support of Cascade Connections. There are many needs in our community and everyone was concerned how we would be able to reach this goal in such a short period of time. On November 17, 2017, Cascade Connections partnered with Haggen Food & Pharmacy and KISM to present the Third Annual Hamster Ball. This event kicked off the fundraising campaign, and allowed many local community members to learn more about Cascade Connections and the campaign that Mark had created. In addition, many community donors contributed during Giving Tuesday, the Tuesday following Thanksgiving which is known as an international day of giving. By December 4th, Cascade Connections had exceeded that goal and were able to purchase the much needed van.

Update on Pine Street Home

There's an old saying that goes, "When God closes a door he opens a window."

This was our journey as Pine Street Home closed its doors as an Adult Family Home on Oct. 31, 2017, and reopened Nov. 1, 2017, as part of Cascade Supported Living in Lynden.

Pine Street Home had operated for ten years as an adult family home, serving six individuals. However, increasing regulations and inadequate funding made it impossible for Cascade Connections to continue operating it as an AFH.

We were troubled by the changes and worried about the future. And that's when we got to work.

Through the efforts (and prayers) of Cascade Connections' representatives, five Pine St. residents were accepted into the DDA Core Waiver program, a generous funding source that provides for supported living and vocational services. Residents could choose to remain with Cascade Connections or choose another program.

If you're doing the math, you may realize that one more resident needed an answered prayer. This gentleman was not eligible for the Core Waiver, but wanted to remain living with his longtime friends and roommates. We requested permission from DDA to have him remain at the house with supports from private care providers and backup from Cascade Supported Living.

No one could have foreseen that our prayers would be answered in this way. Often people eligible for the Core Waiver wait over five years for this funding and are forced to find interim measures to receive the care they need.

Two residents chose to move to Bellingham and closer to work and family. The remaining four residents stayed in Lynden.





The next step: finding affordable housing in Lynden since Pine Street Home was scheduled to be sold after it was closed. This is also a formidable task as residents needed single-level housing, and the ability to access public transportation and other services.

A community member surprised us all when he purchased the home, providing our next blessing. The new owner decided to rent the house to the four remaining gentlemen. If there were even one more person living there, state rules would not have allowed this arrangement. Residents now could remain in their home, close to bus lines, work and, of course, Woods Coffee. This also meant the "move" to supported living did not involve any moving any furniture!

Pine Street Home staff remained with the Supported Living program in Lynden, providing valuable help and resources to Supported Living staff being trained with the Pine Street Home residents. Change is never easy, nor is it seamless. But every step of our path has been paved for us.

Thank you so much for your continued prayer support. We truly recognize that it is your prayers during these times of crisis that keep Cascade Connections' doors open.

God's plans are much better than ours!
